



May 22, 2024 is the one-year anniversary of all Title II providers utilizing ADVANSYS! What a journey it has been!

NCCC College & Career Readiness Assessment Manual 2023-2024 (page 5) REMINDER

Providers are required to submit data electronically using ADVANSYS. All data, including demographics, attendance, and assessments, must be entered at least once per week, and approved within a week of entry.


All Title II-funded programs are required to complete the following actions into ADVANSYS on a weekly basis:

- 1. Enter and approve student registrations
- 2. Update and approve student demographic profiles (as needed)
- 3. Enter and approve student test scores
- 4. Enter and approve student attendance
- 5. Enter and approve student outcomes


Data must be collected for all eligible students receiving services provided by Title II AEFLA funds. This includes individuals in either the Reportable or Participant classification. **Until data is approved, it will not appear in Colleague (attendance hours for FTE) or on federal reports in ADVANSYS.**

- CCR 2023-2024 PY data through Period 9 (July 1 March 31) is now available in Power BI for providers to review. Please remember Power BI is your official source of record for state and federal performance funding.
- Program Performance & Operations will be offering sessions on data management and reporting during the following conferences: IIPS Summer Conference in July (07/22-07/24), CCR Convocation in September (09/18-09/19), and the NCCCS System Office Conference in October (10/13-10/15).

The workshops, led by Lindsay Tipton and Matthew Brown, guided Title II Directors, Coordinators, and IET partners through the comprehensive process of building a Career Pathway and an IET.





The hands-on sessions covered essential stages, from conducting regional scans to addressing workforce needs to the detailed planning of scheduling and logistics.

the workshop with tangible plans ready for implementation. The events were designed to educate and empower educators and coordinators to develop effective and sustainable IET frameworks tailored to the needs of their regions.

Compliance Corner

The deadline for the 2024–25 Title II Continuation Grants was Friday, March 1, 2024. All submissions were received on time and have been thoroughly reviewed by the State Office CCR Team. We are pleased to announce that a total of 69 providers have been approved for continued Title II funding for the 2024–25 program year.

We appreciate the dedication and effort that went into preparing the Continuation Grant Application, and we believe that the continued support and innovative adult education practices will have a significant impact on program participants. HSE Office/CCR Assessment Updates

On March 18, OCTAE announced that NRS approval for all of the ESL assessments that were scheduled to expire on June 30, 2024 would be extended for one year. The impacted assessments include BEST Literacy, BEST Plus 2.0, CASAS Life and Work, and TABE CLAS-E Forms A/B. The new NRS expiration date for these assessments will be June 30, 2025.

At the state level, North Carolina has chosen to extend the use of these assessments until the new 2025 expiration date. The CCR Assessment Office has submitted a revised assessment policy that will allow NC providers to take the extension if they so choose. The updated policy is under review by OCTAE and an announcement will be made when OCTAE has issued an approval decision.

Please keep in mind...

- Providers are still permitted to use the new ESL assessments that were approved for this year (BEST Literacy 2.0, BEST Plus 3.0, and CASAS STEPS); this announcement does not affect their approval.
- This announcement does not include an extension for CASAS Math GOALS. This assessment will *still expire on June 30, 2024* with the expectation that Math GOALS 2 will be used in its place moving forward.
