As providers become more familiar with the budget form with formulas, we anticipate a decrease in common calculation errors in future submissions.

Data & Performance Updates

- CCR 2023–2024 PY data through Period 5 (July 1 November 30) is now available in Power BI for providers. Period 6 has been loaded to Power BI.
- State-level data checks are being conducted on 2023-2024 Periods 1 6 to ensure enrollment, FTE, and MSG calculations are accurate. The performance team will reach out to individual providers when missing data and/or discrepancies are found.
- CCR will host one additional virtual "ADVANSYS Tour" for providers that were unable to attend the in-person sessions in November and December. This tour will occur on *February 15th from 10:00 am - 12:00 pm via Teams*. Select providers who were not able to attend have been invited to this session.
- CCR is in the process of updating the state's Colleague to ADVANSYS manual for providers.

HSE Office/CCR Assessment Updates

CCR providers who use BEST and CASAS assessments will be making the transition to the new assessment series this year! BEST users will begin using the **BEST Literacy 2.0** and **BEST Plus 3.0** tests; CASAS programs will begin using **CASAS Reading STEPS**, **CASAS Listening STEPS** and **CASAS Math GOALS 2**. General training on these test series was provided by the CCR Assessment Office in December 2023. You may also reach out if you would like to schedule a technical assistance call to answe ryour specific questions. The outgoing BEST and CASAS assessments are <u>expiring on June 30, 2024</u>, so please consider your transition strategies soon.
