
Total students served with "non-US-based" location selected on their NRS registration.

These practices will then be broadly implemented across the state. Key topics include but are not limited to:


- Developing and engaging implementation teams

Open to All Providers: All providers are encouraged to apply for the grant(s)

Funding Streams: Three funding streams will be available:

- 1. 231-Adult Education and Family Literacy Act (AEFLA)
- 2. 225-Corrections Education
- **3. 243**-Integrated English Literacy and Civics Education (IEL/CE)









Flexible Application Options: Applicants may choose to apply for one or more funding streams; **READINESS** however, each application must be submitted separately

Review Process: Applications will be reviewed and scored by outside readers • **Note:** State office team members are prohibited from reading or scoring applications

Career Pathways Reminders

- Advising is not only part of the legislation but is imperative to connecting students from IETs to future opportunities in their field through the education and employment.
- Marketing to students outside of your program is key some people will not be motivated to come "back to high school" but are motivated to earn workforce credentials that require a high school diploma or its equivalent.
- Students with IDD are entering Career Pathways through all areas of the community college as part of Access to Achievement. Be sure that CCR is the right fit for a student before automatically enrolling based upon a diagnosis or high school experience.
